



### RENTAL AGREEMENT

The present contract is established between THE EARL DU BORNIER and his customers within the framework of the rent, for one or several nights, of one of the huts situated in height in a tree on the site of the huts of Closed Shanty to Bracquetuit (76).

#### Conditions of access:

- "Rural" Hut: maximum 2 people
- ➤ Hut of the "Witches": 2 to 3 people
- ➤ Hut of the "Farm": 2 to 5 people
- ➤ Hut of the "Undergrowth": 2 to 6 people

The access to the hut of the "Witches, Farm and Undergrowth" is authorized from 2 years and, from 12 years for the "Rural" hut. For safety reasons (location of places, functioning of huts, transmission of the instructions(deposits)) the welcome(reception) is necessarily made of day. It is necessary to you to get organized thus necessarily to arrive on the site before the nightfall.

Only the people having signed the discharge(dump) can reach the hut.

# It is compulsory:

- To warn(prevent) us beforehand in case of health problems (sleepwalking, problems heart patients, eye disorders, dizzinesses).
- To have a mobile phone loaded and lit(phone loaded and switched on, phone in charge of and lit).
- To lock the padlocks of the door, close the gate (s) for every departure of the hut.
- To block(surround) trapdoors (Hut "Rural") or to lock the gate during the night.
- To follow the instructions concerning the dry toilet.
- To indicate any deterioration.
- To leave the clean(appropriate) hut and the terrace, as you found them.

### It is forbidden:

- To reach huts under the influence of drink.
- To smoke inside the hut.
- To throw(cast) cigarette ends or matches used on the terrace, its accesses(neighborhoods) and the whole site.
- To carry(wear) dirty shoes inside huts (plan another pair).
- To light candles, fires(lights), Chinese lanterns (sky lantern) or barbecues in the farm building.
- To leave the terrace of the hut to climb(soar) on the tree or on lifelines (feet have to stay on the floor).

# You are responsible for damages which you cause ...

# In the event of an accident, of fire or big concerns(marigolds):

- Phone to Julie PETIT in 07 70 36 84 21
- Except opening hours, phone in the service of emergencies(urgent matters) adapted (cf. display(posting) in the hut).
- You have at arrangement(measure) a fire extinguisher and a first-aid kit.

I give up any appeal(recourse), as well as my insurers, against The Huts of Closed Shanty in case of non compliance with these instructions(deposits).

I declare to be healthy and not to be the object of sleepwalking, cardiac problems, disorders of view(sight) or of dizzinesses. In case of bad weather during my stay, EARL DU BORNIER informs me that the following procedures are applied: if METEO France announces, for example, gusts of wind superior to 80 km / hour, I would be warned to be rehoused near the domain according to the availability. In this case, I would benefit from a second night in half-price hut, in agreement with the schedule, in 12 current months.
